**TUITION DISCOUNTS**

Early Payment Discount: 3% discount for full payment of tuition by August 10.

Ministry Discount: 10% ministry discount for individuals in full-time ministry. Please submit a letter requesting the discount to GPCS prior to June 1; include job description and contact information for your employer, supervisor, or board of directors.

**FEES (nonrefundable)**

New Student Application: \$25 per student: may be paid at the end of the online application or paid by check to the Main Office.

New Student Registration: \$125 per student is due within 30 days of acceptance in order to reserve child's place

Current Student Registration: \$125 per student due by June 1; increases to \$150 after June 1

Athletic Fees: Elementary teams: \$ 35 per student per sport (individual cap: \$275; family cap: \$400)  
Varsity teams \$125 per student per sport (individual cap: \$275; family cap: \$400)

**GPCS Tuition Assistance Program**

GPCS provides some tuition assistance for mission-appropriate students based on demonstrated need. We use the services of FACTS Grant & Aid Assessment to determine financial need. Families applying for financial aid will need to complete an online application and submit the necessary supporting documentation and \$35 application fee to FACTS by April 30. Financial assistance decisions will be announced as soon as possible after the April 30 deadline. New families applying for enrollment to GPCS after the April 30 deadline may still apply for financial aid.

**Tuition Commitment**

The ministry of GPCS is made possible only by the shared sacrifice of families (in the form of tuition and gifts), of faculty and staff (in the form of significantly lower compensation), and by the gifts of those who appreciate the need for Christian education. While GPCS receives support from a number of area churches, we are not a church-sponsored school and do not have a host congregation to make up budget shortages. For this reason it is essential to the continued ministry of GPCS that families honor their tuition commitment as well as assist in fund-raising and gift-giving as they are able.

**TUITION PAYMENT OPTIONS**

Please choose your tuition payment plan below by June 1; payments are made online through FACTS:

- Early payment in full** by August 10 (receives 3% tuition discount)
- Two payments:** one-half due by August 10 and one-half due by January 10
- 12-month payment plan:** July 10 through June 10 (Registration fee is paid separately by June 1)

The Business Office will start the process of setting up a FACTS account for new families upon receipt of this agreement. Once we have initiated the account, the family will receive an email link from FACTS in order to complete the registration process. Please contact the GPCS Business Office (207-767-5123 x201) with any questions; we are happy to assist.

Paying your tuition through FACTS allows you to check on the status of your account, the schedule of payments, and view payments already made, as well as see a complete listing of all activity for your account. **LATE PAYMENTS & WITHDRAWAL**

**Late payments** and outstanding balances will be handled in the following manner:

1. Payments received after the **10<sup>th</sup> day** of the month will be recorded as late, and the family will be charged a **\$30 late fee**.
2. If there is unpaid tuition at the end of an academic quarter, the student(s) will not be allowed to attend the following academic quarter until the overdue balance is paid in full.
3. Tuition must be paid in full before graduating seniors can receive their diplomas.
4. Students will not be permitted to begin a new school year if a balance is showing for any previous school year.

**Withdrawal:** Students who leave the school for any reason will be charged tuition on a pro-rata basis.

My signature below affirms that I have read and understood GPCS's tuition and fees policies above and agree to the terms and conditions of this agreement. I agree to pay tuition and fees in a timely manner, according to the payment option selected.

I understand that the school's duties and obligations under this Agreement may be suspended indefinitely without notice during all periods in which GPCS is closed due to any force majeure events, including, but not limited to, any earthquake, fire, flooding, act of God, war, governmental action, act of terrorism, epidemic, pandemic, state of emergency, or any other event beyond its control. GPCS will deliver remote instruction as soon as is reasonably practicable and safe under the circumstances. If such a force majeure event occurs, the duties and obligations in this Agreement may be postponed for a period of time until GPCS can deliver its contingency course instruction or until such time as GPCS, in its sole discretion may safely reopen. In the event GPCS is closed for a period of time or must deliver course work remotely due to an event under this clause, I agree the school is under no obligation to cancel, waive, or refund, any portion of tuition that is owed or paid to GPCS.
