TUITION DISCOUNTS & CREDITS

Early Payment Discount:	3% discount for full payment of tuition by August 10.
Ministry Discount:	10% ministry discount for individuals in full-time ministry. To request the discount, please have your supervisor, employer, board of directors, or church leadership team submit a letter with the request to GPCS prior to June 1; the letter must verify your full-time status and position.
Multi-child Discount:	Child #1 & #2 pay full tuition. 10% discount for third child; 25% discount for fourth or more
Kindergarten Credit:	Full-time preschool students will receive a \$350 credit towards Kindergarten the following year. Applicable for the 2025-2026 year for 4-year-old students enrolled in the 5 full day preschool program, with the credit to be applied toward the student's 2026-27 kindergarten tuition.

FEES (nonrefundable)

New Student Application:	\$25 per student: may be paid at the end of the online application or paid by check to the Main Office
New Student Registration:	\$150 per student is due <u>within 7 days</u> of the school's offer of enrollment in order to reserve child's place
Current Student Registration:	\$125 per student due by March 1; increases to \$150 after March 1
Athletic Fees:	Elementary teams: \$ 70 per student per sport
	Middle school teams: \$125 per student per sport
	Varsity teams: \$175 per student per sport

GPCS Tuition Assistance Program

GPCS provides some tuition assistance for mission-appropriate students based on demonstrated need. We use the services of FACTS Grant & Aid Assessment to determine financial need. Families applying for financial aid will need to complete an online application and submit the necessary supporting documentation and \$35 application fee to FACTS by April 15. To access FACTS, please visit our website (www.gpcs.net), click on the Admissions tab, then on Tuition Assistance Program and click the link provided.

Financial assistance decisions will be announced in May. New families applying for enrollment to GPCS after the April 15 deadline may still apply for financial aid.

Tuition assistance may be discontinued at the discretion of the Finance Committee for non-current tuition payment, behavioral issues, or lack of satisfactory academic progress.

Tuition Commitment

The ministry of GPCS is made possible only by the shared sacrifice of families (in the form of tuition and gifts), of faculty and staff (in the form of significantly lower compensation), and by the gifts of those who support our mission. GPCS is not a church-sponsored school and does not have a host congregation to make up budget shortages. Tuition is by far our major source of income. For this reason it is essential to the continued ministry of GPCS that families honor their tuition commitment as well as assist in fund-raising and gift-giving as they are able. *Parents of enrolled students are responsible for tuition for the entire month in which the student is withdrawn, regardless of the day of the month the withdrawal occurs. This includes the months of July and August.*

TUITION PAYMENT OPTIONS

Please choose your tuition payment plan below by June 1. Payments are made online through FACTS. Cash or check may be arranged if payment is to be made in full or as authorized by the treasurer. You must choose one of the options below:

- Early payment in full** by August 10 (receives 3% tuition discount)
- Two payments:** one-half due by August 10 and one-half due by January 10
- 12-month payment plan:** July 10 through June 10 (Registration fee is paid separately by June 1)

The Business Office will start the process of setting up a FACTS account upon receipt of this agreement. Once we have initiated the account, a new family will receive an email link from FACTS in order to complete the registration process (current FACTS users, log in with your user ID and password to check your balance and payment amounts). Cash or check payments may be arranged if payment is to be made in full or if payments are authorized by the treasurer. Paying your tuition through FACTS allows you to check on the status of your account and the schedule of payments, view payments already made, and see a complete listing of all activity for your account. This is not a loan program, so no interest or finance charges are assessed. Visit FACTSmt.com to learn more about the FACTS program.

LATE PAYMENTS & WITHDRAWAL

Late payments and outstanding balances will be handled in the following manner:

1. Payments received more than 7 school days after the regularly scheduled due date will be recorded as late, and the family will be charged a **\$50 late fee**, effective July 1, 2025.
2. If there is unpaid tuition 30-days or more past due at the end of an academic quarter or prior to the start of the academic school year and no alternative arrangements have been agreed to, the student(s) will not be allowed to attend the next academic quarter until the overdue balance is paid in full. The family will be formally notified by the Head of School and unenrolled.
3. Tuition must be paid in full before graduating seniors can receive their diplomas.
4. Students will not be permitted to re-enroll for a new school year if there is any past due tuition balance.
5. All registration/athletic fees must be paid in full before a student can begin school and/or play in a game in any subsequent sport.

Withdrawal: Parents of enrolled students are responsible for tuition for the entire month in which the student is withdrawn, regardless of the day of the month the withdrawal occurs. This includes the months of July and August.

I understand that the school's duties and obligations under this Agreement may be suspended indefinitely without notice during all periods in which GPCS is closed due to any force majeure events, including, but not limited to, any earthquake, fire, flooding, act of God, war, governmental action, act of terrorism, epidemic, pandemic, state of emergency, or any other event beyond its control. GPCS will deliver remote instruction as soon as is reasonably practicable and safe under the circumstances. If such a force majeure event occurs, the duties and obligations in this Agreement may be postponed for a period of time until GPCS can deliver its contingency course instruction or until such time as GPCS, in its sole discretion, may safely reopen. In the event GPCS is closed for a period of time or must deliver course work remotely due to an event under this clause, I agree the school is under no obligation to cancel, waive, or refund, any portion of tuition that is owed or paid to GPCS.
